HEALTH AND HUMAN SERVICES REPORT

Brad Vold, Director, and Karen Szczodroski, reported on program integrity in our financial assistance programs.

A motion was made by Commissioner LeMieur, seconded by Commissioner Wilson to approve a contract with Northern Pines to hire staff for work in the schools using Behavior Strategists. Contract is for up to \$500,000 using ARPA/Lost Revenue dollars as discussed and approved on June 21st. Motion carried on a roll call vote with all Commissioners voting 'aye'.

A motion was made by Commissioner LeMieur, seconded by Commissioner Winscher to approve a County contract with Umbrella Tree out of Bemidji to provide supervised contact for a child. They are a new provider and cost is budgeted for this service.. Motion carried on a roll call vote with all Commissioners voting 'aye'.

A motion was made by Commissioner LeMieur, seconded by Commissioner Jelinski and carried unanimously to approve replacement of Adult Mental Health Social Worker position.

SHERIFF REPORT

A motion was made by Commissioner Jelinski, seconded by Commissioner Winscher and carried unanimously to approve the Resolution#2022-089 authorizing execution of the TZD Grant for 2023 in the amount of \$14,700.00.

Shawn Larsen, County Sheriff, presented the September Monthly Report.

PUBLIC WORKS REPORT

A motion was made by Commissioner Jelinski, seconded by Commissioner Winscher to authorize Public Works director to enter into an agreement with Widseth for professional services for building replacement. Motion carried on a roll call vote with all Commissioners voting 'aye'.

A motion was made by Commissioner Wilson, seconded by Commissioner LeMieur to authorize Public Works director to enter into an agreement with Contegrity Group Inc. for professional services for building replacement. Motion carried on a roll call vote with all Commissioners voting 'aye'.

A motion was made by Commissioner Winscher, seconded by Commissioner LeMieur to approve entering into an agreement with Burns and McDonnell for professional services for Morrison County Solid Waste Facility MPCA Permit reissuance. Motion carried on a roll call vote with all Commissioners voting 'aye'.
